Notice of Availability and Award of Funds
SFY25 New Jersey Hospital Based Violence Intervention Program (NJHVIP)

Take notice that, in compliance with N.J.S.A. 52:14-34.4, the Department of Law & Public Safety (the Department, LPS), Division of Violence Intervention and Victim Assistance (VIVA) announces the availability of the following non-competitive grant program funds:

SFY25 New Jersey Hospital-Based Violence Intervention Program (NJHVIP).

AVAILABLE FUNDING

The State of New Jersey, Division of Violence Intervention and Victim Assistance is making up to \$10,000,000 available to support the NJHVIP. These funds will be offered and awarded to the following non-profit agencies. This continuation funding is limited to those recipients who were funded under the SFY24 NJHVIP Competitive Program, and who have met the goals and objectives of the program, met all reporting requirements in a timely manner, are in compliance with all grant conditions, and any other factors that DLPS may take into consideration.

Funding for the NJHVIP is supported by the SFY25 State Budget and federal American Rescue Plan (ARP) funding, in the amount of \$10,000,000, of which a majority of the grant program is supported by the New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act. In order to maximize the amount of funding available for this program, grants may be issued through one or multiple funding sources. Funding is provided to support programming that connects victims to services beginning in a hospital or other medical setting to services outside of the hospital in order to increase support for victims of crime, improve their outcomes, and reduce future victimization.

Funding is provided on a reimbursement basis only is contingent upon the successful recipient application submission.

Funding is for a 12-month period from January 1, 2025 through December 31, 2025. Applicants may only apply for up to the maximum amount listed below. Grant period extension will not be permitted.

Application packages will be sent via email to eligible applicants. Applicants must complete and submit an application with all applicable documents provided and signatures by January 24, 2025. The provided documents must be used and may not be altered. An applicant that is designated as a high-risk grantee by L&PS is to submit a separate attachment to its application, information that L&PS will use, among other pertinent information, to determine whether it will consider or select the application for an award under this solicitation. The file should be named "L&PS High-Risk Grantee Applicant Disclosure and Justification". Applications must be emailed to the following email address: hvip@njoag.gov, entering "FY25 NJHVIP Non-Competitive Continuation Grants" in the subject line. Applications that do not comply with the requirements of this Notice of Availability of Funds or the Program Administration and Funding Guidelines will not be considered for funding.

The Department reserves the right to decline any and all applications for funding and to award grants in amounts that may be other than requested. The submitted application may be subject to disclosure pursuant to the Open Public Records Act, N.J. S. A. 47:1A-1 et seq.

Award notifications will be made on or about February 21, 2025.

Please note that funding allocations and individual subaward amounts are subject to change. For applications that propose new partnerships, LPS reserves the right to award a smaller grant. Subrecipients shall recognize and agree that both the initial provision of funding and the continuation of such funding under a grant agreement is expressly dependent upon the availability to the Department of funds appropriated by the State or Federal legislature from State and/or Federal revenue to such other funding sources as may be applicable. A failure of the Department to make any payment under a grant agreement or to observe and perform any condition on its part to be performed under a grant agreement as a result of the failure of the State or Federal legislature to appropriate funds shall not in any manner constitute a breach of a grant agreement by the Department or an event of default under a grant agreement because of the absence of available funding appropriations. In addition, future funding shall not be anticipated from the Department beyond the duration of the award period set forth in a grant agreement and in no event shall a grant agreement be construed as a commitment by the Department to expend funds beyond the termination date set forth in a grant agreement.

Please note that applications approved for funding will not be eligible to execute grant award contracts without the submission of all requested documents.
